Under [IC 4-22-2-24](#), [IC 13-14-8-6](#), and [IC 13-14-9](#), notice is hereby given that on **November 10, 2021**, at **1:30 p.m.**, at the Indiana Government Center South, 10 North Senate Avenue, Conference Center Room A, Indianapolis, Indiana, the Environmental Rules Board (board) will hold a public hearing on amendments to rules in [327 IAC 3-5-5](#), [327 IAC 5-3-2](#), [327 IAC 5-21-3](#), [327 IAC 8-3-7](#), [327 IAC 15-16-5](#), [327 IAC 15-16-10](#), and [327 IAC 19-7-1](#) and the addition of [327 IAC 5-3-17](#), [327 IAC 5-21-12](#), and [327 IAC 19-9-2](#) concerning water program permit fees and other directly associated fees as required by the Public Law 250-2019.

The purpose of this hearing is to receive comments from the public prior to consideration of preliminary adoption of these rules by the board. All interested persons are invited and will be given reasonable opportunity to express their views concerning the proposed new and amended rules.
