Community Integration and Habilitation Waiver and the Family Supports Waiver**

In accordance with the public notice requirements of 42 CFR 447.205, Section 1902(a)(13)(A) of the Social Security Act, the Indiana Family and Social Services Administration (FSSA), Office of Medicaid Policy and Planning (OMPP) publishes this change of previous public notice regarding proposed amendments to the Community Integration and Habilitation (CIH) waiver and the Family Supports Waiver (FSW). The fiscal information in the public notice posted on the Indiana Register website on August 27, 2021, at [20210728-IR-405210302ONA](#), was incorrect. The following information from the public notice is also being corrected: The annual cap for SMES maintenance is remaining at \$500, not increasing to \$1000; the annual cap for VMODs maintenance is being set at \$1000, not \$500. The public notice will run October 20, 2021, through November 19, 2021.
