Under [IC 4-22-2-24](#), [IC 13-14-8-6](#), and [IC 13-14-9](#), notice is hereby given that on **June 8, 2022, at 1:30 p.m.**, at the Indiana Government Center South, 10 North Senate Avenue, Conference Center Room A, Indianapolis, Indiana, the Environmental Rules Board (ERB) will hold a public hearing on amendments to rules at [326 IAC 1-4](#), concerning updates to the attainment designation status for ninety Indiana counties under the primary and secondary National Ambient Air Quality Standards for sulfur dioxide, as well as updates to [326 IAC 1-4-65](#) to change the designation status for Porter County under the 2015 8-hour ozone standard.

The purpose of this hearing is to receive comments from the public prior to consideration of adoption of these rules by the board. All interested persons are invited and will be given reasonable opportunity to express their views concerning the proposed amendments.
