**Notice of Changes to Postpartum Coverage**

In accordance with public notice requirements established at 42 CFR 440.386, the Indiana Family and Social Services Administration (FSSA), Office of Medicaid Policy and Planning (OMPP) publishes this notice of proposed amendments to modify an existing Alternative Benefit Plan (ABP) to extend coverage of postpartum care to eligible beneficiaries. The public notice period will run 05/18/2022 to 06/01/2022.

FSSA – OMPP proposes to modify the postpartum coverage service requirements allowing extended coverage for postpartum care. These changes include extending postpartum coverage for eligible women from sixty (60) days to twelve (12) months. These changes will be effective April 1, 2022.

OMPP is making these changes in order to comply with sections 9812 and 9822 of the American Rescue Plan Act of 2021 (ARP), which gives states a new option to provide 12 months of extended postpartum coverage to pregnant individuals beginning April 1, 2022. This Medicaid State Plan Amendment (SPA) would provide ABP coverage for an eligible pregnant woman for the duration of the pregnancy and for the 12-month postpartum period that begins on the last day of the pregnancy (current law is 60 days postpartum coverage).

In accordance with 42 CFR 440.345, the state continues to assure access to early and periodic screening, diagnostic, and treatment (EPSDT) services for any child under 21 years of age eligible under the state plan in a category under section 1902(a)(10)(A) of the Act, as outlined in [405 IAC 5-15](#).

Also, a copy of this notice is now available and may be inspected by contacting the local county Division of Family Resources (DFR) office, except in Marion County, where public inspection may be made at 402 West Washington Street, Room W374, Indianapolis, Indiana.
