SUMMARY OF FINDINGS UNDER IC 4-22-2.6-4

The Indiana Department of Environmental Management (IDEM) is proposing to readopt the listed articles of Title 329 regarding solid waste management without any proposed changes. All the rules proposed for readoption remain necessary and meet the standards set forth in IC 4-22-2-19.5. IDEM has determined that there is a continued need for the listed rules based on state statutory requirements, the ability to administer delegated or authorized federal programs, and to maintain permit, registration, operational, and compliance requirements for solid waste management programs. The details of these programs, rules, and statutory requirements are described in more detail in the previously published legislative notice (20231220-IR-329230812LNA) for LSA Document #23-812.

No less costly or less intrusive alternative methods of achieving the purposes of the rules have been identified. The rules avoid duplicating standards found in state or federal law, are written for ease of comprehension for the entities subject to them, and have practicable enforcement. There have been no significant changes to the cost benefit, fiscal impact, or regulatory burden statements prepared for the initial adoption of the proposed readopted rules.
