

**Notice of Public Comment Period for Rule Readoption**

LSA Document #23-658

Readopts rules in anticipation of [IC 4-22-2.6](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the fifth year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the publisher.

**SUMMARY OF FINDINGS UNDER [IC 4-22-2.6-4](#)**

The rules have a continued need to provide reasonable guidance and certainty for individuals who may be living or working both in and outside Indiana. The issues of individual domicile and residency when an individual moves into or out of Indiana continue to occur and have increased in light of the increased use of remote work in recent years. These three rules meet each of the standards set forth in [IC 4-22-2-19.5](#). In addition, there are no alternative methods of achieving the purpose of the rules that are less costly or less intrusive, or that would otherwise minimize the economic impact of the proposed rules on small businesses.
