### **OVERVIEW**

# **Basic Purpose and Background**

45 IAC 23 is being added to comply with SECTION 15 of Public Law 249-2023. The proposed rule clarifies Indiana's treatment of limited permits, how the department determines applicable limited permits, and the benefits to businesses and the department by minimizing the scope of disputes.

### PROPOSED RULE

SECTION 1. 45 IAC 23 IS ADDED TO READ AS FOLLOWS:

### **ARTICLE 23. LIMITED PERMITS**

### **Rule 1. Limited Permits**

45 IAC 23-1-1 Trip permit

Authority: <u>IC 6-8.1-3-3</u> Affected: <u>IC 9-18.1-13-5</u>

Sec. 1. (a) For purposes of this section, a trip permit may be:

- (1) issued instead of full registration:
- (2) used as directed by the department of state revenue (department) for both interstate and intrastate movement:
- (3) issued for a seventy-two (72) hour period, valid beginning 12:01 a.m. on the initial day designated by the applicant;
- (4) issued only to applicants based in an International Registration Plan jurisdiction;
- (5) issued after payment of a fifteen dollar (\$15) fee to the department; and
- (6) obtained before entering the state of Indiana by the vehicle using the trip permit.
- (b) For purposes of this section, "trip permit" means a limited permit issued by the department to any vehicle allowed to lawfully operate in Indiana.

SECTION 2. 45 IAC 23-1-2 IS ADDED TO READ AS FOLLOWS:

### 45 IAC 23-1-2 Hunter's permit

Authority: <u>IC 6-8.1-3-3</u> Affected: IC 9-18.1-13-6

Sec. 2. (a) A hunter's permit may be:

- (1) issued only to applicants who are both owner and operator of a vehicle;
- (2) issued only to a vehicle previously registered in Indiana or a newly purchased vehicle;
- (3) issued for a thirty (30) day period, valid beginning on the date issued:
- (4) issued after payment of a ten dollar (\$10) fee to the department of state revenue (department);
- (5) renewed only one (1) time after payment of a ten dollar (\$10) renewal fee;
- (6) issued for use by unladen vehicles only; and
- (7) issued to only one (1) combination of vehicles.

(b) For purposes of this section, "hunter's permit" means a limited permit issued by the department allowing a commercial carrier to move their vehicle within Indiana for a limited period while seeking an Indiana load to be transported.
