TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 474. Effective August 31, 2000.

SECTION 1. The name of this instant game is “Instant Game Number 474, Mummy Money”.

SECTION 2. Instant tickets in instant game number 474 shall sell for one dollar (\$1) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 474 shall contain eleven (11) play symbols and play symbol captions all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the upper left corner of the game play data area in a box labeled “WINNING SYMBOL”. Ten (10) play symbols and play symbol captions shall appear in the larger box labeled “YOUR SYMBOLS” arranged in pairs representing pictures and prize amounts.

(b) The play symbols and play symbol captions, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

- (1) A picture of bat
BAT**
- (2) A picture a ghost
GHOST**
- (3) A picture of a spider
SPIDER**
- (4) A picture of a skull
SKULL**
- (5) A picture of monster’s head
MONSTER**
- (6) A picture a tombstone
TOMBSTN**
- (7) A picture of Frankenstein
FRANK**
- (8) A picture of a haunted house
HOUSE**
- (9) A picture of witch’s head
WITCH**

(c) The play symbols representing prize amounts shall consist of the following possible play symbols:

- (1) \$1.00
ONE**
- (2) \$2.00
TWO**
- (3) \$3.00
THR**
- (4) \$4.00
FOUR**
- (5) \$5.00
FIVE**

- (6) \$10.00
TEN
- (7) \$20.00
TWENTY
- (8) \$40.00
FORTY
- (9) \$50.00
FIFTY
- (10) \$100
ONE HUN
- (11) \$1,000
ONE THOU

SECTION 4. The holder of a ticket in instant game number 474 shall remove the latex material covering the eleven (11) play symbols and play symbol captions. If one (3) *[sic.]* or more of “YOUR SYMBOLS” match the “WINNING SYMBOL”, the holder is entitled to a prize of the combined matching prize amounts. The prize amounts and number of winners in instant game number 474 are as follows:

SECTION 5. (a) There shall be approximately three million (3,000,000) instant tickets initially available in instant game number 474.

(b) The odds of winning a prize in instant game number 474 are approximately 1 in 4.93.

(c) All reorders of tickets for instant game number 474 shall have the same:
(1) prize structure;
(2) number of prizes per prize pool of two hundred forty thousand (240,000); and
(3) odds;
as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 474 is April 30, 2001.

SECTION 7. SECTIONS 1 through 6 of this document expire May 31, 2001.
