TITLE 65 STATE LOTTERY COMMISSION

LSA Document #00-195(E)

DIGEST

Temporarily adds rules concerning instant game number 475. Effective August 31, 2000.

SECTION 1. The name of this instant game is “Instant Game Number 475, Make Me A Millionaire”.

SECTION 2. Instant tickets in instant game number 475 shall sell for five dollars (\$5) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 475 shall contain thirty-three (33) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. Three (3) play symbols and play symbol captions shall appear in the area labeled “WINNING NUMBERS”. Thirty (30) play symbols and play symbol captions shall appear in the area labeled “YOUR NUMBERS” and be arranged in pairs representing numbers or pictures and prize amounts.

(b) The play symbols and play symbol captions in instant game number 475, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

(c) The play symbols and play symbol captions representing prize amounts in instant game number 475 shall consist of the following possible play symbols and play symbol captions:

SECTION 4. The holder of a ticket in instant game number 475 shall remove the latex material covering the thirty-three (33) play symbols and play symbol captions. If one (1) or more of the “YOUR NUMBERS” match any of the “WINNING NUMBERS”, the holder is entitled to the prize amount paired with the matched number. If the play symbol of a picture of a bag of money with the play symbol “\$\$BAG” is exposed in the “YOUR NUMBERS” area, the player is automatically entitled to the paired prize amount. A player may win up to fifteen (15) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 475 are as follows:

SECTION 5. The one million dollar (\$1,000,000) prizes will be paid in twenty-five (25) annual installments of forty thousand dollars (\$40,000) unless the winners exercise an option to receive a single, present value, lump sum payment in lieu of annual installments within sixty (60) days after becoming entitled to the prize. Present value determinations are at the sole discretion of the commission. The commission is not liable for present value amounts that are negatively affected by fluctuations in market indicators and other factors beyond its control at the time the option is exercised.

SECTION 6. (a) There shall be approximately three million (3,000,000) instant tickets initially available in instant game number 475.

(b) The odds of winning a prize in instant game number 475 are approximately 1 in 3.11.

(c) All reorders of tickets for instant game number 475 shall have the same:

(1) prize structure;

(2) number of prizes per prize pool of one hundred twenty thousand (240,000); and

(3) odds;

as contained in the initial order.

SECTION 7. The last day to claim a prize in instant game number 475 is December 31, 2004.

SECTION 8. SECTIONS 1 through 7 of this document expire January 31, 2005.
