Temporarily adds rules concerning instant game number 485. Effective August 31, 2000.
SECTION 1. The name of this instant game is "Instant Game Number 485, Wild Money".
SECTION 2. Instant tickets in instant game number 485 shall sell for one dollar (\$1) per ticket.
SECTION 3. (a) Each instant ticket in instant game number 485 shall contain eleven (11) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the box labeled "WINNING NUMBER". Ten (10) play symbols and play symbol captions shall appear in the area labeled "YOUR NUMBERS" and be arranged in pairs representing numbers or pictures and prize amounts.
(b) The play symbols and play symbol captions in instant game number 485, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:
(1) 1

(c) The play symbols and play symbol captions representing prize amounts in instant game number 485 shall consist of the following possible play symbols and play symbol captions:

(5) $\$ 20.00$

SECTION 4. The holder of a ticket in instant game number 485 shall remove the latex material covering the eleven (11) play symbols and play symbol captions. If one (1) or more of "YOUR NUMBERS" match the "WINNING NUMBER", the holder is entitled to the prize amount paired with the matched number. If the play symbol "WILD" and the play symbol caption "DOUBLE" appear in the "YOUR NUMBERS" area, the player is automatically entitled to the paired prize amount. A player may win up to five (5) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 485 are as follows:

SECTION 5. (a) There shall be approximately four million five hundred thousand $(4,500,000)$ instant tickets initially available in instant game number 485.
(b) The odds of winning a prize in instant game number 485 are approximately 1 in 4.91 .
(c) All reorders of tickets for instant game number 485 shall have the same:
(1) prize structure;
(2) number of prizes per prize pool of two hundred forty thousand $(240,000)$; and (3) odds;
as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 485 is November 30, 2001.
SECTION 7. SECTIONS 1 through 6 of this document expire December 31, 2001.
