TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 492. Effective October 20, 2000.

SECTION 1. The name of this instant game is "Instant Game Number 492, Couch Change".

SECTION 2. Instant tickets in instant game number 492 shall sell for one dollar (\$1) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 492 shall contain seven (7) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the small box labeled "PRIZE BOX". Six (6) play symbols and play symbol captions representing coins with stated denominations shall appear in two (2) rows in the large box.

- (b) The play symbols and play symbol captions in instant game number 492, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:
 - (1) A picture of a coin containing the denomination 01¢ PENNY
 - (2) A picture of a coin containing the denomination 05¢ NICKL
 - (3) A picture of a coin containing the denomination 10¢ DIME
 - (4) A picture of a coin containing the denomination 25¢ QRTER
 - (5) A picture of a coin containing the denomination 50¢ HALF
- (c) The play symbols and play symbol captions representing prize amounts in instant game number 492 shall consist of the following possible play symbols and play symbol captions:
 - (1) \$1.00
 - **ONE**
 - (2) \$2.00
 - **TWO**
 - (3) \$5.00
 - **FIVE**
 - (4) \$10.00
 - TEN
 - (5) \$25.00
 - TWY FIVE
 - (6) \$50.00
 - **FIFTY**
 - (7) \$100
 - ONE HUN
 - (8) \$500
 - FIV HUND
 - (9) \$1,000
 - **ONE THOU**

SECTION 4. The holder of a ticket in instant game number 492 shall remove the latex material covering the seven (7) play symbols and play symbol captions. If the total of the coin denominations in the large box is greater than one dollar (\$1), the holder is entitled to the prize amount in the "PRIZE BOX". The prize amounts and number of winners in instant game number 492 are as follows:

SECTION 5. (a) There shall be approximately four million five hundred thousand (4,500,000) instant tickets initially available in instant game number 492.

- (b) The odds of winning a prize in instant game number 492 are approximately 1 in 4.91.
- (c) All reorders of tickets for instant game number 492 shall have the same:
- (1) prize structure;
- (2) number of prizes per prize pool of two hundred forty thousand (240,000); and
- (3) odds;

as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 492 is December 31, 2001.

SECTION 7. SECTIONS 1 through 6 of this document expire January 31, 2002.
