TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 493. Effective December 14, 2000.

SECTION 1. The name of this instant game is “Instant Game Number 493, Royal 7’s”.

SECTION 2. Instant tickets in instant game number 493 shall sell for one dollar (\$1) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 493 shall contain fourteen (14) play symbols and play symbol captions all concealed under a large spot of latex material. The play symbols and play symbol captions shall be arranged in pairs representing numbers, pictures, and prize amounts along the bottom half of each instant ticket.

(b) The play symbols and play symbol captions, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

- (1) 1
ONE**
- (2) 2
TWO**
- (3) 3
THR**
- (4) 4
FOR**
- (5) 5
FIV**
- (6) 6
SIX**
- (7) 7
SVN**
- (8) 8
EGT**
- (9) 9
NIN**
- (10) A picture of a crown
WIN**

(c) The play symbols representing prize amounts shall consist of the following possible play symbols:

- (1) \$1.00
ONE**
- (2) \$2.00
TWO**
- (3) \$4.00
FOUR**
- (4) \$7.00
SEVEN**
- (5) \$14.00
FOURTEEN**

(6) \$777
SVHN SVTSVN

SECTION 4. The holder of a ticket in instant game number 493 shall remove the latex material covering the fourteen (14) play symbols and play symbol captions. If one (1) or more play symbols and play symbol captions representing prize amounts are paired with the play symbol and play symbol caption associated the number seven (7), the holder is entitled to a prize of the combined matching prize amounts. If one (1) play symbol and play symbol caption representing a prize amount is [*sic., are*] paired with the play symbol and play symbol caption associated with a crown, the holder is automatically entitled to a prize of ten dollars (\$10). A holder may win up to seven (7) times on a ticket. The matches, prize amounts, and number of winners in instant game number 493 are as follows:

SECTION 5. (a) There shall be approximately four million (4,000,000) instant tickets initially available in instant game number 493.

(b) The odds of winning a prize in instant game number 493 are approximately 1 in 4.92.

(c) All reorders of tickets for instant game number 493 shall have the same:

- (1) prize structure;
- (2) number of prizes per prize pool of two hundred forty thousand (240,000); and
- (3) odds;

as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 493 is February 28, 2002.

SECTION 7. SECTIONS 1 through 6 of this document expire March 31, 2002.
