**TITLE 65 STATE LOTTERY COMMISSION**

LSA Document #00-281(E)

**DIGEST**

Temporarily adds rules concerning instant game number 498. Effective December 14, 2000.

**SECTION 1. The name of this instant game is “Instant Game Number 498, Red Hot Hearts”.**

**SECTION 2. Instant tickets in instant game number 498 shall sell for one dollar (\$1) per ticket.**

**SECTION 3. (a) Each instant ticket in instant game number 498 shall contain fourteen (14) play symbols and play symbol captions all concealed under a large spot of latex material. The play symbols and play symbol captions shall be arranged in pairs representing pictures and prize amounts along the bottom half of each instant ticket.**

**(b) The play symbols and play symbol captions, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:**

**(1) A picture of diamond**

**DIMND**

**(2) A picture a rose**

**ROSE**

**(3) A picture of a gift**

**GIFT**

**(4) A picture of chiming bells**

**BELLS**

**(5) A picture of heart**

**HEART**

**(6) A picture a stack of currency**

**CASH**

**(7) A picture of a cupid**

**CUPID**

**(8) A picture of a teddy bear**

**BEAR**

**(9) A picture of a piece of candy**

**CANDY**

**(10) A picture of a bow and arrow**

**BOW**

**(11) A picture of an envelope**

**CARD**

**(12) A picture of a cake**

**CAKE**

**(c) The play symbols representing prize amounts shall consist of the following possible play symbols:**

**(1) \$1.00**

**ONE**

**(2) \$2.00**

**TWO**

**(3) \$3.00**

**THREE**

- (4) \$4.00  
FOUR
- (5) \$7.00  
SEVEN
- (6) \$10.00  
TEN
- (7) \$14.00  
FOURTEEN
- (8) \$21.00  
TWY ONE
- (9) \$500  
FIVE HUN

SECTION 4. The holder of a ticket in instant game number 498 shall remove the latex material covering the fourteen (14) play symbols and play symbol captions. If one (1) or more play symbols and play symbol captions representing prize amounts are paired with play symbols and play symbol captions associated with a heart, the holder is entitled to a prize of the combined matching prize amounts. A holder may win up to seven (7) times on a ticket. The prize amounts and number of winners in instant game number 498 are as follows:

SECTION 5. (a) There shall be approximately four million five hundred thousand (4,500,000) instant tickets initially available in instant game number 498.

(b) The odds of winning a prize in instant game number 498 are approximately 1 in 4.94.

(c) All reorders of tickets for instant game number 498 shall have the same:

- (1) prize structure;
- (2) number of prizes per prize pool of two hundred forty thousand (240,000); and
- (3) odds;

as contained in the initial order.

**SECTION 6. The last day to claim a prize in instant game number 498 is January 31, 2002.**

**SECTION 7. SECTIONS 1 through 6 of this document expire March 31, 2002.**
