Dear Members of the Committee,

Pursuant to the provisions of IC 4-22-2-19(c), this letter shall serve as written notification that sections 2, 3, 4, 5, 6, 7, 11 and 13 through 23 of the above-captioned rule do not comply with IC 4-22-2-19(c)(1). These sections create new certifications of *Rescue Technician-Rope Rescue*, *Rescue Technician-Surface Water Rescue*, *Rescue Technician-Vehicle and Machinery Rescue*, *Rescue Technician-Confined Space Rescue*, *Rescue Technician-Structural Collapse Rescue*, *Rescue Technician-Trench Rescue*, *Instructor-Swift Water Rescue*, *Swift Water Rescue Technician*, *Public Information Office*, *Juvenile Firesetter Intervention Specialist I* and *Juvenile Firesetter Intervention Specialist II*. The reasons for the noncompliance are as follows:

1. Pursuant to IC 22-14-2-7(c)(7), the Board of Firefighting Personnel Standards and Education is authorized to adopt rules to create a program of voluntary certification for fire service personnel and programs. This statute was effective in 1987.

2. The additions to the Board's rules contained in the sections cited above create classifications based on (i) the need to break out various types of rescue technician specialties to permit certification in only the areas that are needed for a particular fire department response, (ii) the necessity of providing a trained group of specialists in the area of swift water rescue, (iii) the growing importance of qualified personnel to interact with the media on behalf of fire department, and (iv) properly trained personnel to respond to the growing problem of fires set by children. These classifications were not contemplated at the time of the 1987 statute, and are extremely important in ensuring that properly trained fire and emergency response personnel are able to respond effectively and efficiently to the emergency needs of Indiana in the 21st century.
