TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 508. Effective February 22, 2001.

SECTION 1. The name of this instant game is "Instant Game Number 508, On A Roll".

SECTION 2. Instant tickets in instant game number 508 shall sell for one dollar (\$1) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 508 shall contain eighteen (18) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. The play symbols and play symbol captions shall be arranged in a matrix of six (6) rows and three (3) columns. The rows shall be labeled "ROLL 1", "ROLL 2", "ROLL 3", "ROLL 4", "ROLL 5", and "BONUS ROLL". The third column shall be labeled prize.

(b) The play symbols and play symbol captions, other than those of prize amounts, shall consist of the following possible play symbols and play symbol captions:

(1) 1 ONE (2) 2 TWO (3) 3 THR (4) 4 FOR (5) 5 FIV (6) 6 SIX

(c) The play symbols and play symbol captions of prize amounts shall consist of the following possible play symbols and play symbol captions:

(1) \$1.00 ONE (2) \$2.00 TWO (3) \$3.00 THREE (4) \$5.00 FIVE (5) \$6.00 SIX (6) \$10.00 TEN (7) \$20.00 TWENTY (8) \$35.00 THY FIVE (9) \$70.00 SEVENTY
(10) \$700.00 SVN HUN
(11) \$1,000.00 ONE THOU
(12) \$2,000.00 TWO THOU
(13) \$7,000.00 SVN THOU

SECTION 4. The holder of a ticket in instant game number 508 shall remove the latex material covering the eighteen (18) play symbols and play symbol captions. If the first two (2) play symbols and play symbol captions total seven (7) or eleven (11) when added, the holder is entitled to the prize amount for that roll. If the first two (2) play symbols and play symbol captions in the "BONUS ROLL" total (7) or eleven (11) when added, the holder is entitled to five (5) times on a ticket. The prize amounts and number of winners in instant game number 508 are as follows:

SECTION 5. (a) There shall be approximately four million five hundred thousand (4,500,000) instant tickets initially available in instant game number 508.

(b) The odds of winning a prize in instant game number 508 are approximately 1 in 4.78.

(c) All reorders of tickets for instant game number 508 shall have the same:

(1) prize structure;

(2) number of prizes per prize pool of two hundred forty thousand (240,000); and

(3) odds; as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 508 is February 28, 2002.

SECTION 7. SECTIONS 1 through 6 of this document expire March 31, 2002.
