TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 520. Effective March 22, 2001.

SECTION 1. The name of this instant game is "Instant Game Number 520, Nifty 50".

SECTION 2. Instant tickets in instant game number 520 shall sell for one dollar (\$1) per ticket.

SECTION 3. Each instant ticket in instant game number 520 shall contain ten (10) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the small box labeled "BONUS". Nine (9) play symbols and play symbol captions shall appear in the larger, unlabeled box. The play symbols and play symbol captions in instant game number 520 shall consist of the following possible play symbols and play symbol captions:

(1) \$1.00

ONE

(2) \$2.00

TWO

(3) \$5.00

FIVE

(4) \$15.00

FIFTEEN

(5) \$50.00

FIFTY (6) \$550

FIV HUNFTY

SECTION 4. The holder of a ticket in instant game number 520 shall remove the latex material covering the ten (10) play symbols and play symbol captions. If three (3) matching play symbols and play symbol captions are exposed in the larger, unlabeled box, the holder is entitled to a prize of the matched amount. If two (2) matching play symbols and play symbol captions are exposed in the larger unlabeled box and the same play symbol and play symbol caption is exposed in the "BONUS" box, the holder is entitled to a prize of the matched amount. The prize amounts and number of winners in instant game number 520 are as follows:

Matching Play Symbols	Prize Amount	Approximate Number of Winners
3 matches of \$1.00	\$1	456,000
3 matches of \$2.00	\$2	192,000
3 matches of \$5.00	\$5	84,000
3 matches of \$15.00	\$15	12,000
3 matches of \$50.00	\$50	13,500
3 matches of \$550	\$550	8

SECTION 5. (a) There shall be approximately three million six hundred thousand (3,600,000) instant tickets initially available in instant game number 520.

- (b) The odds of winning a prize in instant game number 520 are approximately 1 in 4.75.
- (c) All reorders of tickets for instant game number 520 shall have the same:
- (1) prize structure;
- (2) number of prizes per prize pool of two hundred forty thousand (240,000); and
- (3) odds;

as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 520 is March 31, 2002.

SECTION 7. SECTIONS 1 through 6 of this document expire April 30, 2002.
