**EXECUTIVE ORDER:** 01-03

**FOR:** THE CREATION OF THE INDIANA LAND USE FORUM

**TO ALL TO WHOM THESE PRESENTS MAY COME, GREETINGS:**

**WHEREAS**, the importance of establishing a land use policy that addresses farmland preservation, wildlife habitat and natural resources protection, open space development and urban revitalization cannot be overstated; and

**WHEREAS**, the state took initial action to establish these policies by creating the Hoosier Farmland Preservation Task Force and the Indiana Land Resources Council; by directing state agencies to locate regional offices in downtowns and historic districts; by providing financial incentives to redevelop brownfields in Hoosier communities; and by conducting a Conference on the Environment dedicated solely to the discussion of land use policies; and

**WHEREAS**, further development of land use policies will continue to be an important issue in the 21<sup>st</sup> Century as Indiana's population grows and technological advances make it easier for Hoosiers to live and work in widely dispersed communities; and

**WHEREAS**, efforts to manage Indiana's land resources should be primarily carried out at the local level in order to preserve the unique character of Hoosier communities and to ensure their economic well being; and

**WHEREAS**, state actions, especially in the areas of transportation, taxation, the environment, economic development and infrastructure often have a direct impact on local government; and

**WHEREAS**, state government is uniquely positioned to continue the collaborative effort develop a coordinated and balanced land use policy.

**NOW THEREFORE**, I, Frank O'Bannon, by virtue of the authority vested in me as Governor of the State of Indiana by the Constitution and laws of this state, do hereby ORDER that:

1. The Indiana Land Use Forum (hereafter "Forum") is established.
2. The Forum shall be chaired by the Governor's Executive Assistant for the Environment: and consist of the following members:
  - Assistant Commissioner of the Office of Agriculture;
  - Chairman of the State Tax Board;
  - Chairman of the Utility Regulatory Commission;
  - Commissioner of the Department of Administration;
  - Commissioner of the Department of Environmental Management;
  - Commissioner of the Department of Health;
  - Commissioner of the Department of Workforce Development;
  - Commissioner of the Department of Transportation;
  - Director of the State Budget Agency;
  - Director of the Department of Natural Resources;
  - Executive Director of the Department of Commerce;
  - Executive Director of the Development Finance Authority;
  - Executive Director of the Housing Finance Authority;
  - Executive Director of the Land Resources Council; and
  - Utility Consumer Counselor.
3. The Forum shall submit recommendations no later than one year from the date of this order on how state government shall work together with local government and the private sector to develop a coordinated and balanced land use policy.
