Temporarily adds rules concerning instant game number 530. Effective June 8, 2001.
SECTION 1. The name of this instant game is "Instant Game Number 530, Draw Poker".
SECTION 2. Instant tickets in instant game number 530 shall sell for one dollar (\$1) per ticket.
SECTION 3. (a) Each instant ticket in instant game number 530 shall contain twelve (12) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. Two (2) play symbols and play symbol captions representing playing cards shall appear in the area labeled "DRAW CARDS". Ten (10) play symbols and play symbol captions shall appear in the area labeled "YOUR CARDS" and be arranged in pairs representing playing cards or a joker and prize amounts.
(b) The play symbols and play symbol captions in instant game number 530, other than those representing prize amounts, shall represent playing cards and consist of the following possible play symbols and play symbol captions:
(1) A

(c) The play symbols and play symbol captions representing prize amounts in instant game number 530 shall consist of the following possible play symbols and play symbol captions:

SECTION 4. The holder of a ticket in instant game number 530 shall remove the latex material covering the twelve (12) play symbols and play symbol captions. If one (1) or more of "YOUR CARDS" match either of the "DRAW CARDS", the holder is entitled to the prize amount paired with the matched playing card. If the play symbol of a picture of an acorn with the play symbol caption "JOKER" is exposed in the "YOUR CARDS" area, the player is automatically entitled to the paired prize amount. A player may win up to five (5) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 530 are as follows:

SECTION 5. (a) There shall be approximately four million $(\mathbf{4 , 0 0 0 , 0 0 0 )}$ instant tickets initially available in instant game number 530.
(b) The odds of winning a prize in instant game number 530 are approximately 1 in 4.96.
(c) All reorders of tickets for instant game number 530 shall have the same:
(1) prize structure;
(2) number of prizes per prize pool of two hundred forty thousand $(\mathbf{2 4 0 , 0 0 0})$; and (3) odds;
as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 530 is May 31, 2002.
SECTION 7. SECTIONS 1 through 6 of this document expire June 30, 2002.
