## TITLE 65 STATE LOTTERY COMMISSION

## **DIGEST**

Temporarily adds rules concerning instant game number 538. Effective July 11, 2001.

SECTION 1. The name of this instant game is "Instant Game Number 538, Sunny Money".

SECTION 2. Instant tickets in instant game number 538 shall sell for one dollar (\$1) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 538 shall contain seven (7) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the area labeled "LUCKY NUMBER". Six (6) play symbols and play symbol captions shall appear in the area labeled "YOUR NUMBERS" and be arranged in pairs representing numbers and prize amounts.

(b) The play symbols and play symbol captions in instant game number 538, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

(1) 1

ONE

(2) 2

TWO

(3) 3

THR

(4) 4

**FOR** 

(5) 5 FIVE

(6) 6

SIX

**(7)** 7

SVN

(8) 8

EGT

(c) The play symbols and play symbol captions representing prize amounts in instant game number 538 shall consist of the following possible play symbols and play symbol captions:

(1) \$1.00

**ONE** 

(2) \$2.00

**TWO** 

(3) \$5.00

**FIVE** 

(4) \$10.00

TEN

(5) \$20.00

**TWENTY** 

(6) \$50.00

FIFTY

(7) \$100 ONE HUN (8) \$500 FIVE HUN (9) \$3,000 THR THOU

SECTION 4. The holder of a ticket in instant game number 538 shall remove the latex material covering the seven (7) play symbols and play symbol captions. If one (1) or more of the "YOUR NUMBERS" numbers match the "LUCKY NUMBER" number, the holder is entitled to the prize amount paired with the matched number. A player may win up to three (3) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 538 are as follows:

SECTION 5. (a) There shall be approximately three million six hundred thousand (3,600,000) instant tickets initially available in instant game number 538.

- (b) The odds of winning a prize in instant game number 538 are approximately 1 in 4.53.
- (c) All reorders of tickets for instant game number 538 shall have the same:
- (1) prize structure;
- (2) number of prizes per prize pool of two hundred forty thousand (240,000); and
- (3) odds;

as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 538 is March 30, 2002.

SECTION 7. SECTIONS 1 through 6 of this document expire April 30, 2002.
