Under IC 12-8-3-4.4, LSA Document #01-172, printed at 24 IR 3179, which amends 405 IAC 1-12-24 to assess community residential facilities for the developmentally disabled (CRFs/DD) and intermediate care facilities for the mentally retarded (ICFs/MR) not operated by the State in an amount not to exceed ten percent (10%) of annual gross residential services revenue of the facility for the facility's preceding fiscal year was adopted by the Office of the Secretary of Family and Social Services on August 6, 2001. The rule which was adopted is the same version as the proposed rule which was published in the Indiana Register on July 1, 2001.

Under IC 12-8-3-4.4, LSA Document #01-214, printed at 24 IR 3756, which amends 405 IAC 5-31-8 to eliminate bed hold days for Medicaid certified and enrolled nursing facilities with less than ninety percent (90%) occupancy was adopted by the Office of the Secretary of Family and Social Services on September 10, 2001. The rule which was adopted is a different version than the proposed rule which was published in the Indiana Register on August 1, 2001.

LSA Document #01-53, printed at 24 IR 3756, adds 440 IAC 9-2-4, 440 IAC 9-2-5, and 440 IAC 9-2-6 to establish standards and requirements for community mental health centers and certified managed care providers regarding acute stabilization, day treatment, and services to prevent unnecessary and inappropriate treatment and hospitalization and the deprivation of a person's liberty as part of the required continuum of care for persons needing addiction services, persons with serious mental illness, or children with serious emotional disorders. The rule was adopted by the Director of the Division of Mental Health and Addiction, Janet Corson, on September 7, 2001. The rule that was adopted is identical to the proposed rule which was published in the Indiana Register on August 1, 2001.
