#### DIGEST

Adds 905 IAC 1-48 to establish rules requiring permittees, in all instances involving off-premises sales not conducted in a package store, to obtain proper legal identification from persons seeking to purchase alcoholic beverages. Allows certain specific exceptions. Effective 30 days after filing with the secretary of state.

SECTION 1. 905 IAC 1-48 IS ADDED TO READ AS FOLLOWS:

Rule 48. Obtaining Proof of Age Required; Exceptions

905 IAC 1-48-1 Obtaining proof of age required; exceptions

Sec. 1. (a) All sales for off-premises consumption shall require proper legal identification from persons seeking to purchase alcoholic beverages to determine that the person is twenty-one (21) years of age or older.

(b) The requirements of subsection (a) shall not be deemed necessary if the permittee's clerk has actual knowledge that the person attempting to purchase alcoholic beverages is twenty-one (21) years of age or older or if the clerk has articulable facts to believe that the person is twenty-eight (28) years of age or older. (Alcohol and Tobacco Commission; 905 IAC 1-48-1)
