## DIGEST

Temporarily adds rules concerning instant game number 569. Effective December 21, 2001.
SECTION 1. The name of this instant game is "Instant Game Number 569, Sizzlin' 7’s".
SECTION 2. Instant tickets in instant game number 569 shall sell for one dollar (\$1) per ticket.
SECTION 3. (a) Each instant ticket in instant game number 569 shall contain ten (10) play symbols and play symbol captions all concealed under a large spot of latex material. Nine (9) play symbols and play symbol captions shall appear in matrix of three (3) rows and three (3) columns. One (1) play symbol and play symbol caption shall appear in a box labeled "PRIZE".
(b) The play symbols and play symbol captions, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:
