Under IC 12-8-3-4.4, LSA Document #01-175, printed at 24 IR 4136, which adds 405 IAC 2-3-1.2 concerning Medicaid penalties for transferring assets for less than fair market value, and specifies that the purchase of an annuity or similar arrangement is considered a transfer of assets for less than fair market value unless the annuity is irrevocable, commercially issued, actuarially sound, and provides substantially equal monthly payments with no balloon payment, was adopted by the Office of the Secretary of Family and Social Services on March 6, 2002. The rule that was adopted is a different version from the proposed rule published in the Indiana Register on September 1, 2001.

Under IC 12-8-3-4.4, LSA Document #01-372, printed at 25 IR 1242, which amends 405 IAC 5-24-4 and 405 IAC 5-24-6 to revise reimbursement policy for pharmacy services in the Medicaid program, including adding a state maximum allowable cost schedule to the Medicaid reimbursement methodology for legend drugs, was adopted by the Office of the Secretary of Family and Social Services on April 9, 2002. Note: Under IC 4-22-2-29(a)(2), LSA Document #01-303, printed at 25 IR 847, was consolidated with this document. The rule that was adopted is a different version from the proposed rules published in the Indiana Register on December 1, 2001 (LSA Document #01-303) and January 1, 2002 (LSA Document #01-372).

Under IC 12-8-3-4.4, LSA Document #01-393, printed at 25 IR 1683, which amends 405 IAC 2-3-3 to exclude impairment-related work expenses in calculating income for Medicaid eligibility for the aged, blind, and disabled, and adds 405 IAC 2-9 to set out eligibility requirements for Medicaid for employees with disabilities (MED works), was adopted by the Office of the Secretary of Family and Social Services on April 3, 2002. The rule that was adopted is a different version from the proposed rule published in the Indiana Register on February 1, 2002.

LSA Document #01-420

Under IC 12-8-3-4.4, notice is hereby given that LSA Document #01-420, printed at 25 IR 1690, was adopted by the Secretary of the Family and Social Services Administration on April 9, 2002. The rule amends 405 IAC 1-12 to establish Medicaid reimbursement criteria for certain Community Residential Facilities for the Developmentally Disabled (CRFs/DD) licensed as small extensive medical needs residences for adults. Sets a limit of 12 hours per resident day for staffing costs for a four bed facility that is exclusively for adults with extensive medical needs. The rule that was adopted is identical to the proposed rule published in the Indiana Register on February 1, 2002, at 25 IR 1690.
