OVERVIEW: Amends 312 IAC 5-6-6 that provides restricted watercraft zones on Lake Wawasee to replace 10 miles per hour speed limits with expanded idle speed zones and watercraft prohibition zones on Lake Wawasee and Syracuse Lake for the protection of ecological resources. OVERVIEW: Amends 405 IAC 5 to add humidification, and solutions used for humidification, to a Medicaid-enrolled nursing facility's per diem rate. Makes other conforming changes. Statutory authority: IC 12-8-6-5; IC 12-15-1-10; IC 12-15-21-2.

TITLE 460 DIVISION OF DISABILITY, AGING, AND REHABILITATIVE SERVICES

Under IC 4-22-2-3, the Division of Disability, Aging, and Rehabilitative Services intends to adopt a rule concerning the following:

OVERVIEW: Adds provisions regarding the hire of a fiscal agent by an individual in need of self-directed in-home care who has hired a personal services attendant pursuant to 460 IAC 1-8, including duties, qualifications, and registration requirements of the fiscal agent, methods of payment for a personal services attendant and fiscal agent, and record keeping requirements.
