DIGEST

Temporarily adds rules concerning scratch-off game number 797. Effective January 27, 2006.

SECTION 1. The name of the scratch-off game is "Scratch-Off Game Number 797, Office Pool".

SECTION 2. Scratch-off tickets in scratch-off game number 797 shall sell for one dollar (\$1) per ticket.

SECTION 3. Play symbols: A scratch-off ticket in "Scratch-Off Ticket Game Number 797, Office Pool" shall contain a total of nine (9) play and prize spots with three (3) independent games labeled "GAME 1", "GAME 2", and "GAME 3". Three (3) play spots (one (1) per game) located under area labeled "YOUR SCORE", three (3) play spots (one (1) per game) located under area labeled "PRIZE" for each game. The play symbol captions that appear in scratch-off game number 797 shall consist of the following possible play symbols and play symbol captions:

THEIR SCORE Play Symbols:

SECTION 4. Prize symbols: One (1) prize spot is located directly under each respective game play area. Prize symbol captions correspond with and verify each of the prize symbols as follows:

GAME 1 – GAME 3 PRIZE Symbols

SECTION 5. Retailer validation codes: The retailer validation code verifies instant winners of "\$1", "\$2", "\$4", "\$5", "\$10", "\$20", "\$40", and "\$100". The retailer validation code which corresponds with and verifies each of these winners is as follows:

\$1 = ONE

\$2 = TWO

\$4 = FOR

\$5 = FIV

\$10 = TEN

\$20 = TWY\$40 = FRY\$100 = HUN

SECTION 6. How to win: A prize winner in "Scratch-Off Game Number 797, Office Pool" is determined by removing the entire scratch-off material from the play area on the front of the ticket to reveal six (6) play spots and three (3) prize spots in three (3) independent games labeled "GAME 1", "GAME 2", and "GAME 3". Neither the retailer validation code (nor any portion thereof), the pack-ticket number (or any portion thereof), nor the validation number (or any portion thereof) are play symbols or prize symbols and are not usable or playable as such. If the holder's "YOUR SCORE" beats "THEIR

SCORE" in a single game, the holder is entitled to win the prize represented for that game. If a "DOUBLE" (basketball symbol) is revealed, the holder is entitled to win DOUBLE the prize indicated in the area labeled "PRIZE" for that associated game.

SECTION 7. Prize structure: The possible winning prize combinations are as follows:
